Facility: Skyline Aquatic Center, 845 S. Crismon, Mesa, Arizona 85208

Directions: Take the US-60 East Freeway toward Mesa-Globe to the Crismon exit #192, turn left (North) on S. Crismon and proceed approximately 1 mile to the Skyline Aquatics Center located on the campus of Skyline High School.

Parking: Free parking is available in the Kino Junior High School parking lot.

Course: Outdoor. Competition pool is 25 yards, 8 lanes will be used for competition, 8 short course yard lanes will be available for continuous warm-up.

Time: Warm-ups begin at 8:30am. Meet begins at 9:30am

Entries: Swimmers are limited to a maximum of 5 events. The 1650 will be limited to the first 16 entries received. Entries are due by Saturday, February 11th. Then promptly send a check for \$25 and a copy of your 2012 USMS registration card and the USMS Release of Liability Form (attached) to Mesa Aquatics Club, c/o Erin Shields, 1957 E. Fairmont Dr., Tempe, AZ 85282. You can also mail entries with using the consolidated entry form located at www.azlmsc.org

Check In: Positive check in is required for the 1650 by 9:00am the day of the event and for the 500 Free and 400 IM by 10:00am. Swimmers in the 1650 must provide their own timer and lap counter.

Seeding: All events will be seeded slowest to fastest, by entered time, ages and sexes combined.

Entry Fees: There is a \$25.00 flat fee per swimmer
