- Course:** Eight lane, outdoor, 25 yard pool with non turbulent lane lines, Colorado state and automatic timing system, several lanes in a separate warm-up pool will be available throughout the meet
- Eligibility:** Any swimmer with a valid 2009 USMS registration or a valid travel permit from another country is eligible. Each swimmer must submit a copy of their 2009 USMS registration card or travel permit. Failure to submit proof of registration will result in the entry being rejected. - Rules:** 2009 USMS rules apply. All events are timed final. Swimmers are limited to a total of 6 events. Swimmers that enter all 6 events will be eligible for High Point Awards in their age group. Age on November 8, 2009 determines the age group of the swimmer for the entire meet. There will be a 5-10 min warm-up following each event.
- Seeding:** All events will be pre-seeded, slowest to fastest, men and women combined. Absolutely no deck entries or late entries will be accepted.

Affiliation: A swimmer's club affiliation as stated on the consolidated entry card will apply throughout the meet, except that a swimmer may be unattached at any time.

Scoring: Fastest cumulative time in all 6 events will determine the high point winner for each age group for male and female.

Awards: Male and female high point awards for each age group will be awarded.

Entries and fees: Entries must be postmarked by November 1, 2009. Absolutely no deck entries and no email or fax entries will be accepted. A flat entry fee of \$25. Please use the Arizona consolidated entry card: fill it out completely (front and back) and include event numbers and seed times for all events you plan to swim.
